The 25th anniversary of the landmark WPS agenda in 2025 presents a critical opportunity to assess its effectiveness and redefine its relevance in the evolving context of the Arab Region. Despite the progress made on the adoption of the WPS agenda in the region, significant challenges and gaps remain in achieving its full implementation and potential, particularly when it comes to conflict affected areas within the region. This necessitates a renewed focus on (but not limited to) 1) Ensuring women's meaningful participation in peace processes and decision-making at all levels; 2) Addressing the specific needs and priorities of women in conflict and post-conflict settings and; 3) Adapting the WPS agenda to address the changing security landscape in the region.

Objectives of the WPS Working Group

To address the above issues, the WPS Regional Hub at the Issam Fares Institute for Public Policy and International Affairs, through its partnership with UN Women ROAS and together with a consortium of other regional and global partners have established the WPS Working Group in June 2024 with the aim of creating a regional mechanism to



influence and inform WPS policy spaces in preparation for the 25th anniversary of the agenda. To achieve this, a series of consultations with a diverse group of WPS stakeholders from the region will be undertaken in 2024-2025 with the aim of analyzing existing WPS frameworks and identify gaps in implementation.

The main outcome of the working group is to develop concrete recommendations for strengthening the implementation of the WPS agenda in the Arab Region through a white policy paper, targeting the annual debate of the UN Security Council on WPS in October 2024, and throughout the 2025 anniversary year of UNSCR 1325. In addition, the working group aims to facilitate enhanced regional cooperation and collaboration among group members on WPS issues in the region, including by encouraging joint advocacy. Finally, the working group will aim to increase visibility and influence of the Arab Region in global WPS discourse.

Iraq

Eman Abdul Rahman

Eman Abdul Rahman is a prominent figure in the field of women's rights in Iraq. She has worked in civil society organizations since 2004. As the head of the Women's Leadership Institute, she played a vital role in promoting women's rights and empowering them, focusing on developing women's leadership skills and providing a supportive environment for them. She is also the head of the Iraqi Network for Resolution 1325, a network of 16 organizations spread across Iraq, which aims to enhance the role of women in peace processes and decision-making.

Eman Abdul Rahman has worked on formulating many national strategies and local and national plans aimed at achieving gender justice and is considered one of the leading advocates for women's rights in Iraq.

Jordan

Dr. Salma Nims

Dr. Salma Nims is an independent expert in gender equality, social inclusion, and WPS. She is Senior Social Affair Officer, Gender Equality and Social Inclusion, at the UN ESCWA. She was the Secretary-General of the Jordanian National Commission for Women (JNCW) between 2014-2022. Dr Nims holds a PhD. in Development Planning (2004) and MSc. in Sustainable Development (1998) from University College London.

Kuwait

Alia Al-Khaled

Alia Al-Khaled is a Kuwaiti political activist advocating for women's rights and community health. She was elected to Kuwait's 2022 National Assembly, being only one of the two women to take office as a parliamentarian. In her capacity as a lawmaker, she sat on two committees involving education and special needs. Alia's professional profile lies in journalism and the health sector. She worked at local media outlets such as Al-Anbaa and Al-Qabas, after serving as a General Manager at Al-Omooma Hospital. She has a Master's degree in in Business Administration, with a focus on sustainability, from Hult International Business School in the UAE.

Dr. Nourah Shuaibi is an Assistant Professor of Political Science at Kuwait University, specializing in GCC-EU relations. Her research interests encompass Political Economy, Counterterrorism, Energy Policy, and Security Studies. Rima Nazzal

Political and women rights activist, a member in the Palestinian National Council, a member in the general secretariat for the Palestinian Women Union, and the president of Al Najdeh Association for Women Development in the West Bank. A specialized writer in women affairs, she has many publications in this field such as: the Palestinian woman book, the Act "1325" and a book about the effects of the occupation and the siege on the Palestinian women and the participation of the Palestinian women in the national rule. A coordinator for the national women coalition for implementing the Act "1325". Moreover, she participated in setting the plan and vision for the Act. Also, through her membership in the higher committee, she participated in setting the strategic frame for the act and the national plan for Palestine.

Qatar

Dr. Zarga Parvez

A political sociologist and social scientist, Dr. Zarqa Parvez studies nationalism, national identity, and gender studies in the Arab Gulf region. As a scholar of international government, her research also engages international politics, Gulf studies and women's studies. She focuses mainly on women, youth, and the politics of identity in state-society dynamics of the Gulf region, for example, framing intersectionality and women's rights in the Arab Gulf Region and studying youth and social media trends. Her research uses both an intersectional and post-colonial lens to further a comprehensive understanding of society, and to also bring to light marginalized and invisible voices. Her work goes beyond the dominant narratives to explore multiple venues of knowledge, taking a more inclusive approach toward issues of identity, policy-making and research agendas. She has held Post-Doctoral fellowship and taught at International Politics department at Georgetown University in Qatar. She has previously taught at Northwestern University in Qatar, Hamad Bin Khalifa University in Qatar, and Lusail University in Qatar.

Dr. Amal Mohammed Al-Malki is a Qatari scholar, educator, public speaker, social commentator and advocate of women's rights and gender equality. Dr. Al-Malki holds a PhD in Comparative Literature from the University of London – SOAS, where she also earned a Master's degree in English-Arabic Applied Linguistics and Translation.

Huda Shafig is a Gender Specialist from Sudan, recognized for her profound contributions to advancing gender justice, women's political participation, and social equity. Her work has consistently centered on the critical nexus of Gender, Natural Resource Management, and Peacebuilding, addressing some of the most pressing challenges in these areas. Ms. Shafig has held pivotal roles within national and international organizations, as well as with the United Nations, where she has been instrumental in driving initiatives that promote gender equality and sustainable peace in Sudan and the broader region. Her extensive expertise is backed by a robust academic foundation; she holds a Bachelor's degree in Political Science and a Master's degree in Coexistence and Conflict from Brandeis University.

Her efforts contributed to building robust partnerships with governmental and civil society actors, leading to the development of Palestine's first- and second-generation National Action plans on WPS, and to the organization of flagship dialogues that amplified Palestinian women's voices on peace and security issues. Sarah Douglas

Sarah Douglas has worked on women, peace and security for over twenty years and is currently the Deputy Chief of the Peace and Security Section in UN Women's New York Headquarters. Prior to this appointment, she served as the Gender Adviser at the UN Peacebuilding Support Office. Previously, she was a Policy Specialist in the Peace and Security team, leading the section's work on gender-responsive peacebuilding. She led UN Women's work in integrating gender and women's issues into security sector reform, disarmament, demobilization and reintegration, community security and arms control, and other stability processes. Prior to joining UN Women, she worked for UNDP and the UN Mission in Sudan (UNMIS) on DDR and Community Security and Arms Control programmes in South Sudan, Darfur, Eastern Sudan and the Three Transitional areas, ensuring that gender and women's issues were integrated throughout programme design, implementation and monitoring.
